



# Cooperation Between Domestic and Foreign Investors: Case Puuilo (Listed on Main Market in 2021)

Risto Tuomaala founded Puuilo, a family business, in Kainuu in 1982. His son Markku and Markku's wife Päivi took over the company in 1985.

In the beginning, trade was conducted at a market, and the first store was established in Kajaani in 1998. Puuilo sold, among other things, household items. Tuomaala's sold the majority stake of Puuilo to a Finnish private equity investor, Sentica Parters.

During the four years of ownership, the Puuilo chain expanded into a country-wide operator. Swedish private equity investor Adelis Equity Partners bought the majority of Puuilo. The company developed by leaps and bounds: in five years, the turnover increased by 250 percent.

Puuilo was listed on Helsinki Main Market in the summer of 2021.






# Finnish Private Equity Investors Have Increasing Amount of Funds to Be Invested



### Assets Under Management and Dry Powder of Finnish PE Funds






### Venture Capital and Buyout Investments in Finnish Companies


