



## **Private Equity**

## **Startup**

A young and innovative company that typically strives for rapid international growth with a scalable business model.

## **Venture capital (VC)**

**Venture** capital investors invest in startups at different growth stages, becoming **minority owners** in their portfolio companies.

## **Growth** company

A company with established business operations, revenue, & potential for continued growth. Revenue can range from a few million to hundreds of millions.

## **Buyout & growth**

**Buyout and growth** investors target more established growth companies. The investments can be **majority or minority investments.** The minority investments are often called growth investments..



Investments made by Finnish VCs.




## Venture capital H1/2023

Statistics in brief

- Finnish startups raised a total of €102m of venture capital funding,
   of which €71m came from Finnish VCs and €31m from foreign VCs.
- A total of **91** Finnish startups raised VC funding.
- In addition, 11 Finnish startups raised a total of €168m in later stage
   VC-growth investments from domestic and foreign investors..
- Finnish VC investors invested a total of €104m, of which €33m in foreign startups.
- A total of 125 startups received funding from Finnish VC investors.
- Finnish VC funds raised a total of €265m in new funds for future investments.


## Investments in Finnish startups dropped significantly

#### €549m

The amount raised by Finnish startups from domestic and foreign investors in the first half of the year.

The amount has dropped significantly, especially when considering the mega-funding rounds of previous years.

Startup funding has similarly declined elsewhere in Europe and the United States.






## Biggest drop seen in later-stage investments


## The number of Finnish companies receiving investments stable

### 102 companies

The number of companies that received domestic or foreign VC and growth investments in H1 remained at the level of previous years.

While the number of companies has remained steady, the amount of funding decreased significantly in the early part of the year.



Domestic and foreign VC investments in Finnish startups






## Later-stage investments in decline – early-stage picking up

Examining VC investments on a quarterly basis provides a more detailed picture of the decline in later-stage investments.

Seed and early-stage investments have turned upward and are at a historically good level.


## Foreign investments in Finnish startups declined the most

#### €71m

The amount invested by Finnish VCs declined from previous years.

### €31m

Foreign VC investments in Finnish startups decreased more in comparison to domestic ones.

### 87 companies


The number of startups receiving domestic VC investments stayed at the level of previous years.


## ICT companies received the most investments

#### 51%

Approximately half of the companies that received VC investments during the first half of the year operate in the ICT sector.

The ICT sector includes, for example, software, applications, communication and computer technology, as well as electronics.

## VC investments in Finnish companies by industry H1/2023 (nbr companies)



of exits were write-offs, which is near previous years' average.


#### **VC exits from Finnish startups**












## Amount invested by Finnish VC and growth investors declined











### 9 companies


were successfully exited in January-June 2023.




## Record fundraising for Finnish VC funds

New funds were published by Lifeline Ventures (€150m) and Voima Ventures (€90m+) in January-June 2023.


### Fundraising of Finnish venture capital funds






## Fundraising of Finnish venture capital funds in 2013–2023







## Investments by Finnish venture capital and private equity investors









## Venture capital and private equity investments in Finnish companies








## Private equity investors H1/2023

Venture capital, growth and buyout statistics in brief

- Finnish venture capital and private equity investors invested a total of 396 M€ into 159 domestic and foreign growth companies
- 129 Finnish startup and growth companies received a total of
   554 M€ in investments.
- Foreign private equity and venture capital investors invested into 18 Finnish companies a total of 190 M€ as an investments.
- Finnish venture capital and private equity investors made successful exits from 14 companies
- New funds raised by Finnish venture capital funds, totaling
   €272m in H1/2023, will be invested in start-up and growth companies in the coming years







## Methodology

The statistics describing the Finnish private equity industry are based on information received from European Data Cooperative (EDC) private equity database

- A fully functional, centralised non-commercial pan-European private equity database
- With its own staff, internal resources and webportal
- Information is collected via an online survey and complemented with public sources of information
- Figures are updated continuously and are therefore subject to change

Note: The statistics include only VC/PE firms' (including evergreens and captives) investments. Syndicate and direct investments made by several other investors, e.g. LP co-investors, individuals, entrepreneurs, business angels, management, corporates, funds-of-funds, other asset managers and/or financial institutions, are not included in FVCA's statistics. However, they may form a notable part of the venture market. Additionally, growth investments' classification to buyout investments affects the venture statistics.



## Methodology

Investment and divestment statistics are aggregated via two methods – industry statistics and market statistics

### **Industry statistics**

- By country of private equity firm's office
- Here: Domestic and foreign investments/divestments made by the Finnish offices of private equity firms

#### **Market statistics**

- By the location of the portfolio company
- Here: Investments/divestments in/from Finnish portfolio companies made by domestic and foreign private equity firms

Note: The aggregated figures may not always sum up to totals due to rounding. Some graphs exclude variables labelled as 'unspecified'.

## **Growth**

- These statistics include growth investments in startups ("**VC-growth"**) to give a more complete picture of the Finnish startup ecosystem's development.
- As Finnish startups have grown, more and more funding has been raised from growth-stage investors, who traditionally make minority investments in relatively mature companies.
- Growth investments in Finnish startups rose to a new level during 2021-2022. VC-growth investments have been added to selected graphs in the report from years 2021-2023.
- A more comprehensive analysis of the VC-growth investments will be provided in following reports.
