

### **Private equity**

### Startup

A young and innovative company that typically strives for rapid international growth with a scalable business model.

### **Growth company**

A company with established operations, revenue & potential for continued growth. Revenue can range from a few million to hundreds of millions.

### **Venture capital**

#### Venture capital investors

make **minority** investments in startups in different growth stages.

### Growth


**Growth investors** make **minority** investments in both later-stage startups and establised but still small growth companies.

### **Buyout**

**Buyout investors** make **majority** investments in established businesses, typically mid-sized growth companies.




### **Buyout & growth 2024**

Statistics in brief

- A total of **€1 017m** (+268%) were raised in buyout and growth funds for future invetments.
- Finnish buyout and growth investors invested a total of €683m (+31%) in 55 (-5%) companies.
- Almost all of the investments by Finnish buyout and growth investors were made in Finnish companies.
- Finnish buyout and growth investors made exits from 21 (+40%) portfolio companies without a single write-down.
- 65 (-6%) Finnish growth companies received a total of €895m (-52%) in investments from Finnish and foreign investors.
- Finnish and foreign buyout and growth investors exited **25** (+56%) Finnish companies without a single write-down.







# Investments



### Buyout and growth investments in Finnish companies

### €895m

Investments received by Finnish companies declined by -52% compared to the previous year. However, the investment amount in 2024 was at a historically average level.

The number of Finnish target companies decreased by -6% compared to the previous year, reaching the second-lowest level in a 10-year time series.

### Foreign and domestic buyout and growth investments in Finnish companies

### €668m

In 2024, domestic buyout and growth investors made a record €668 million in investments in Finnish companies.

### €227m

Foreign buyout and growth investments in Finnish growth companies declined by -83% compared to the previous year, accounting for most of the overall decrease in investment volume.


## B2B firms most popular investment targets


Companies throughout Finland raised buyout and growth investments


After Uusimaa, second-highest amount of investments were made into Southwest Finland.

# Exit market rebounded at year-end


### **25 divestments**

Domestic and international buyout and growth investors exited 25 Finnish companies, representing a 56% increase compared to 2023.

### 10 Exits in Q4

40% of the year's exits occurred in the final quarter. The last time the number was higher was in Q1/2021.


#### Divestments by buyout and growth investors from Finnish






# Strong year for buyout and growth fundraising

### €1bn

In 2024, Finnish buyout and growth investors raised the thirdlargest amount in history. Higher amounts have been raised only in 2007 and 2021.

New funds were announced by CapMan, DevCo, Sponsor Capital, and Evli.



#### Fundraising of Finnish buyout and growth funds





# Investments



### Total amount to new record helped by single large investment

### €683m

Investments by Finnish buyout and growth investors in growth companies increased by +31% from 2023. This growth was driven by an exceptionally large single investment.

### **55** companies

In 2024, Finnish buyout and growth investors invested in 55 companies, a -5% decrease, marking the lowest level on record.




### Finnish investors believe in Finnish companies

# **Divestments**

### Exits rebounded at yearend


### 21 exits

Domestic buyout and growth investors exited 21 companies, representing a 40% increase compared to 2023.

### 9 exits in Q4

43% of last year's exits occurred during the final quarter. The last time exit activity was higher was in Q2/2022.






# Fundraising of Finnish private equity investors

### **€1.3bn**

Fundraising by Finnish private equity funds reached the second-highest level of all time, with an increase of over +70% compared to 2023.

### Fundraising of Finnish private equity funds






### Investments by Finnish venture capital and private equity investors

### **€1.1bn**

Investments by Finnish private equity investors increased by 30% in 2024.

Growth was seen in both venture capital and buyout investments.




### Venture capital and private equity investments in Finnish companies

### €1.3bn

Private equity investments in Finnish companies decreased by -42% from 2023.

The total amount of funding for more mature growth companies (BO-Growth & Buyout) declined, while VC investments saw a slight increase.


The number of companies that received investments from domestic and foreign private equity investors increased by +4%.

### Private equity investors 2024

Venture capital, growth and buyout statistics in brief

- Finnish venture capital and private equity investors invested a total of €882m (+24 %) and €177m (+75 %) in domestic and foreign companies, respectively.
- Finnish companies received a total of €1.3bn (-42 %) in private equity investments, with a total of 273 (+4 %) companies receiving investments.
- New capital raised by Finnish buyout, growth and venture capital funds, totalling **€1.3bn** (+70 %) in 2024, will be invested in startups and growth companies in the coming years.





# Methodology

The statistics describing the Finnish private equity industry are based on information received from European Data Cooperative (EDC) private equity database.

- A fully functional, centralised non-commercial pan-European private equity database.
- With its own staff, internal resources and webportal.
- Information is collected directly from VC/PE investors via an online survey and complemented with public sources of information.
- Figures are updated continuously and are therefore subject to change.

Note: The EDC statistics include only VC/PE firms' (including evergreens and captives) investments. Syndicate and direct investments made by several other investors, e.g. LP co-investors, individuals, entrepreneurs, business angels, management, corporates, funds-of-funds, other asset managers and financial institutions, are not included in EDC statistics. The activity falling outside EDC's methodology is however included in the figures in the section "Investments in Finnish startups".



### Methodology

Investment and divestment statistics are aggregated via two methods – industry statistics and market statistics

### **Industry statistics**

- By country of private equity firm's office
- Here: Domestic and foreign investments/divestments made by the Finnish offices of private equity firms

### **Market statistics**

- By the location of the portfolio company
- Here: Investments/divestments in/from Finnish portfolio companies made by domestic and foreign private equity firms

Note: The aggregated figures may not always sum up to totals due to rounding. Some graphs may exclude unspecified variables.
