




Introduction

- Answers for the private equity and venture capital barometer was collected by Finnish Venture Capital Association on 11.–15.3.2024. The purpose of the survey is to asses the sentiment in the private equity and venture capital, and the sentiment of financing the startup and growth companies.
- The survey was sent to 468 employees of Finnish private equity and venture capital companies, and a total of 110 answers were received.
- It was possible to answer anonymously, but based on the filled-in personal details, the participation in the survey was from at least 35 different private equity firms.





Do you find it easier or more difficult to raise funds than 6 months ago?






*Do you think it will it be easier or more difficult to raise funds in next 6 months?

Do you think that there are more or less investment opportunities than 6 months ago?




Do you think it is easier or more difficult to make exits than 6 months ago?












Fundraising of growth funds still difficult

Do you find it easier or more difficult to raise funds than 6 months ago?



Do you think that there are more or less investment opportunities than 6 months ago?




Do you think it is easier or more difficult to make exits than 6 months ago?








Fundraising of VC funds is slightly more challenging








^{*}Do you think it will it be easier or more difficult to raise funds in next 6 months?

Do you think that there are more or less investment opportunities than 6 months ago?






*Do you think that there will be more or less investment opportunities in next 6 months?

Do you think it is easier or more difficult to make exits than 6 months ago?






*Do you think it will be easier or more difficult to make exits in next 6 months?

Finding a foreign investor is somewhat challenging


VC investors: Do you think that it is easier or more difficult to find foreign investors for your target companies than 12 months ago?





*VC: Do you think it will be easier or more difficult for your target companies to find foreign investors over the next 6 months?







Do you find it easier or more difficult to raise funds than 6 months ago?






*Do you think it will it be easier or more difficult to raise funds in next 6 months?

Do you think that there are more or less investment opportunities than 6 months ago?



Methodology

The survey of the Spring 2024 was sent to 468 employees of Finnish private equity and venture capital companies, and a total of 110 answers were received. It was possible to answer anonymously, but based on the filled-in personal details, the participation in the survey was from at least 35 different private equity firms.

The survey has been conducted by using qualitative questions of fundraising, investment opportunities and exits. Responses have been converted into numerical balance scores according to the guidelines of Statistics Finland, to make ist easier to track investors' sentiments over the long-term. Balance score can range between +100 and -100. A positive score means optimistic and negative pessimistic view of fundraising, investment opportunities or exits.
